Change of Alternate Director

The Company is pleased to announce that Ms. Carolina Yip Lai-ching has been appointed to the post of Deputy Commissioner for Transport/Transport Services and Management and has therefore, by virtue of her appointment, become an Alternate Director to the Commissioner for Transport (Mr. Robert Charles Law Footman) with effect from 23 May 2005.

The Commissioner for Transport is a non-executive Director of the Company appointed by the Chief Executive (the "Chief Executive") of the Hong Kong Special Administrative Region pursuant to the Mass Transit Railway Ordinance (Chapter 556 of the Laws of Hong Kong) (the "MTR Ordinance") and has appointed the Deputy Commissioner for Transport/Transport Services and Management as its Alternate Director.

Ms. Yip (aged 52) has not entered into any contract of service with the Company and nor is Ms. Yip appointed for a specific term. Pursuant to the Articles of Association of the Company, Directors appointed by the Chief Executive pursuant to the MTR Ordinance are not required to retire by rotation at the annual general meetings of the Company.

Ms. Yip is not related to any Directors, senior management or substantial or controlling shareholders of the Company except that she holds the post of Deputy Commissioner for Transport/Transport Services and Management and the Financial Secretary Incorporated, which holds shares in the Company in trust for the Government of the Hong Kong Special Administrative Region, is a controlling shareholder of the Company. As at the date of this announcement, Ms. Yip was not interested in any shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance ("SFO") as recorded in the register required to be kept under section 352 of the SFO or as otherwise notified to the Company and The Stock Exchange of Hong Kong Limited pursuant to the Model Code for Securities Transactions by Directors of Listed Issuers.

The Company hereby also announces that as Mrs. Judy Li Wu Wai-lok ceased to hold the post of Deputy Commissioner for Transport/Transport Services and Management, she also ceased to be an Alternate Director to the Commissioner for Transport. There is no matter relating to her ceasing to be an Alternate Director of the Company that needs to be brought to the attention of the Company's shareholders.
