

**MTR to Launch QR Code Payment at MTR Stations**

Customers will be able to take the MTR by simply tapping their mobile phones at ticket gates at MTR stations, starting from mid-2020. The MTR Corporation today (15 November 2018) awarded a contract to AlipayHK to introduce QR code-based payment as a new payment option at MTR ticket gates for passengers' convenience.

Under the contract, AlipayHK will design and progressively build a new electronic payment system, including QR code scanners at designated entry/exit gates at all stations as well as back-end equipment in the heavy rail network (except Airport Express stations). AlipayHK is required to develop a system which is compatible with QR code-based payment systems to be used by other service providers. Under the contract, AlipayHK has 12 months' exclusivity in using the system it has developed and built, after which the Corporation has the right to bring in more service providers to use the system for QR code payment so as to provide more options to passengers. "The Corporation has been keeping close tabs on changing customer needs and technology trends. Under Rail Gen 2.0 programme, we are committed to providing our passengers with quality services through continuous investment so as to further enhance their travelling experience," said Ms Jeny Yeung, Commercial Director of MTR Corporation. "Mobile payment has been an important focus of the Corporation's efforts in digital transformation in the past few years. We have successfully launched QR code payment for the Airport Express and introduced Ticket Machines and Vending Machines that accept mobile payment at designated stations since 2015. We are delighted to be taking a major step forward in making payment more diversified and convenient for our passengers through the collaboration with AlipayHK."

The introduction of QR code payment will also serve as a pilot to provide valuable experience for the Corporation's future asset replacement programme.
