

「機場快綫 2 重賞」條款及細則

1. 香港鐵路有限公司（「港鐵公司」）推出名為「機場快綫 2 重賞」的特別限時活動（「活動」），所有於 MTR Mobile 已連結八達通的 MTR Mobile 會員（「合資格會員」）均可參與此活動。
2. 活動日期為 2026 年 5 月 27 日至 6 月 30 日（首尾兩天包括在內）（「活動期間」），以港鐵列車服務時間為準。
3. 第一賞：合資格會員於活動期間，使用已連結 MTR Mobile 賬戶的八達通（「合資格八達通」），乘搭機場快綫往返機場站或博覽館站及香港、九龍或青衣站（起點站或終點站必須為機場站或博覽館站）（「合資格車程」），可獲得 1,000 MTR 分。每位合資格會員於活動期間只可獲得一次，1,000 MTR 分將於 2026 年 7 月 17 日或之前透過 MTR Mobile 存入合資格會員之賬戶。
4. 第二賞：合資格會員於活動期間，使用合資格八達通，乘搭合資格車程，即可參加抽獎而無須額外登記。合資格會員每完成一程合資格車程可獲得抽獎機會一次。
5. 所有合資格車程均以港鐵公司的紀錄為準。

9. 「國泰航空雙人商務艙來回機票（指定航線）」所指之指定航線，為由香港出發來回以下其中一個指定目的地之航線。目的地包括：北京、上海、台北、東京、大阪、首爾、曼谷、新加坡、吉隆坡及峇里島。換領期為 2026 年 7 月 20 日至 2026 年 8 月 31 日，最遲出發期 2026 年 12 月 31 日。所有機票均不包括任何稅項及附加費，並須受一般條款、合約條款、票務規則及其他相關條款及細則約束。如對機票詳情有任何查詢，請自行聯絡航空公司。

" Airport Express Double Rewards" Terms and Conditions

1. MTR Corporation Limited ("MTRCL") launches " Airport Express Double Rewards" ("the Campaign"). MTR Mobile members with a linked Octopus ("Eligible Members") can participate.
2. The Campaign runs from 27 May 2026 to 30 June 2026 (both dates inclusive) ("Campaign Period"), based on MTR train service hours.
3. 5. Eligible Ride will be counted based on the records from MTRCL as final.
6. The Lucky Draw will be held on 10 July 2026 ("Lucky Draw Day"). A total of 10,501 winners will be randomly drawn by a computer system of MTR from all the Eligible Members enrolled in the Lucky Draw. Each Eligible user can only win the Lucky Draw prize once.
7. The list of winners will be published in the Sing Tao Daily and The Standard on 17 July 2026.

Winners of the " Airport Express Fare Discount valued at HK\$25" must purchase the Airport Express Round Trip or Single Journey Adult QR code Ticket (to/from Airport Station and Hong Kong, Kowloon or Tsing Yi Station) via the "MTR Online Ticketing Service" to enjoy the discount valued at HK\$25. The Promo Code can only be used once. Members must enter the Promo Code during checkout in order to enjoy the discount valued at HK\$25.
12. Each "MTR Online Ticketing Service" transaction can only use one Promo Code and cannot be used together with other promo codes.
