

迪士尼綫快樂同行二十年 — 20 倍積分賞」條款細則

1. 活動推廣期為 2025 年 8 月 1 日至 31 日（「推廣期」），包括首尾兩日。
2. 於推廣期內，MTR Mobile 的會員使用已連結 MTR Mobile 之八達通每付費乘搭一程經「迪士尼站」出入閘之車程（「合資格車程」），除基本獎分 \$1 = 5 MTR 分（「基本獎分」），可享有額外 \$1 = 95 MTR 分（「額外獎分」），總共 \$1 = 100 MTR 分（「迪士尼綫 20 倍積分賞」）。
3. 合資格車程只適用於用已連結八達通乘搭有效及付費的「迪士尼站」出入閘車程。額外獎分不適用於經 MTR Mobile 連結第三方電子錢包支付平台以車票二維碼乘搭有效及付費的港鐵車程。
4. 上述符合賺取額外獎分優惠的合資格付費車程必須同時符合賺取基本 MTR 分的條件，額外獎分將於乘搭合資格付費車程日起計三 (3) 個工作天內記入其有效的登記賬戶內。迪士尼綫 20 倍積分賞須受 MTR 分推廣條款及細則約束。

1. This promotion period of the 20x MTR Points Reward is from 1 to 31 August 2025 (“Promotion Period”), both days inclusive.
2. During the Promotion Period, MTR Mobile member can earn extra MTR Points at \$1 = 95 MTR Points (“Bonus Reward”), on top of basic entitlement of HK\$1 = 5 MTR Points (“Basic Reward”), to make up a total of HK\$1 = 100 MTR Points (“DIS Ride 20x Points”), by using the linked Octopus for every paid ride to or from Disneyland Resort Station (“Eligible MTR Ride”).
3. Eligible MTR Ride transaction refers to taking a valid and paid MTR ride to or from Disneyland Resort Station with a linked Octopus ONLY. Bonus Reward is NOT applicable to valid and paid MTR rides with QR Code Ticket via MTR Mobile linked to third party electronic payment portal.
4. In order to qualify for the Bonus Reward, the Eligible MTR Ride transactions mentioned above must also fulfill the criteria for earning MTR Points. The Bonus Reward will be credited automatically into the registered user’s valid registered account within three (3) working days from the date of travel. DIS Ride 20x Points will also be bound by the MTR Points Promotion Terms and Conditions.
5. All records from the system database of MTRCL are the only official and correct version.
6. The Contracts (Rights of Third Parties) Ordinance shall not apply to the terms and conditions herein.
7. MTR reserves the right to alter the promotion mechanics and terms and conditions at any time without prior notice. In case of any dispute, the decision of MTRCL shall be final and binding.
