

## HSBC RewardCash Limited-time Offer Terms and Conditions

1. The promotion period of the limited-time offer is from 4 May – 30 June 2026, both dates inclusive (“**promotion period**”).
2. During the promotion period, MTR Mobile members will get 450 MTR Points for every \$1 RewardCash converted from HSBC Reward+ app (“**Reward+**”), cap at the first \$150 RewardCash converted. An MTR free domestic ride - e-Single Journey Ticket (“**special reward**”) is only applicable to MTR Mobile members who converted at least \$10 RewardCash into MTR Points during promotion period and did not convert any RewardCash to MTR Points through HSBC Reward+ from 4 May 2025 to 3 May 2026, both dates inclusive (“**eligible members**”).
