- 3. Neither the Company nor its agents would assume any obligation or liability whatsoever in connection with the transmission of the login details or any use of the login details for voting or otherwise.

LOG IN PROCEDURES

1. Visit https://web.lumiconnect.com/865927192

Meeting ID: "865-927-192" will be displayed on screen.

Press "Join Meeting".

Note: Only one device is allowed per login.

2. Enter your "**username**" and "**password**" (please refer to "Login details" set out on page 1 of this "User Guide" for details).

Then press "Login".

3. After being successfully authenticated, you will be taken to the Home Screen.



BROADCAST VIEWING

4. Press the broadcast button " T BROADCAST " at the bottom of the screen. The broadcast will start automatically when the Meeting commences.

When viewing on a computer or other electronic devices, the broadcast will appear on the right side of the screen automatically once the Meeting starts. There may be delay to the broadcast, depending on the speed of your internet connection.

Select your preferred language (English / Cantonese / Putonghua) under the broadcast screen for the live webcast.



VOTING

5. To ensure your votes are timely counted, you are recommended to cast your vote on the resolutions early in time. The resolutions will be open for voting from the commencement of the Meeting and you need not wait until the Chairman of the Meeting announces commencement of the poll.

Press the voting tab " <u>voting</u>", the screen will display a list of all the resolutions and the voting options. You may scroll through the list to view the resolutions and cast your votes.

- Select "For" or "Against" to cast your vote. Your vote will be highlighted and a confirmation message will appear. Splitting of votes is not allowed for the online platform.
- To change your vote, re-select your choice to override.
- To cancel your vote, press "Cancel".
- To <u>abstain</u> from voting, <u>do not press</u> "For" or "Against" when the poll is called.
- The options you selected when the poll for all resolutions is closed will be your final votes.

At any time during the Meeting, you can go to the Voting page to cast your votes on the resolutions by clicking the voting tab " voting tab ".

SUBMISSION OF QUESTIONS

 Questions can be submitted starting from the commencement of the Meeting until the close of the Q&A session.

Select the messaging tab " exercise ", type your question in the text box and click the send button " > " to submit.

POINTS TO NOTE:
